In accordance with a letter of agreement between Los Angeles College Faculty Guild - Local 1521, hereinafter referred to as CLIENT and the American Arbitration Association, hereinafter referred to as A.A.A., an Election of Officers was conducted among the membership of the union.

Four thousand two hundred fifty-two (4,252) ballots were mailed to the members of the CLIENT on March 30, 2020. During the course of the election, an additional forty-five (45) members were added and one hundred five (105) changes of address and/or requested duplicates were mailed out. In order for the ballots to be valid and counted, the return envelopes furnished to the members, were required to be received by the Foy Station Post Office by 12:00 midnight, Tuesday April 28, 2020.

The CLIENT provided the A.A.A. with an alphabetical list of persons who were eligible to vote. Due to COVID-19 the counting of the ballots took place remotely via Zoom conference for all observers while ballot count was conducted at the Holiday Inn in Diamond Bar, California on Thursday, April 30, 2020. Secrecy of the ballot was maintained at all times.

As a result of the totals, a run-off was deemed necessary in the West Campus Chapter President, position. The results are certified to be as follows:
